- **Financial Review with Bruce-** Bruce Bell had taken time to go through the billing methods to see if there was a better option for the association assessments. He concluded that there was no need for a change at this time, as homeowners liked knowing in advance what their assessments will be.
- **Private Road Committee-** Private road committee will look at all privately maintained roads throughout the association. The committee will involve members of each project, and be led by Charlie, Bruce & Sharon. Map of private roads is being developed by HOA Management.
- **Park Refresh Committee-** Charlie, Jacob, David & Scott had volunteered to assist with the park refresh. Replacement of basketball hoops, procuring new park benches, and picnic tables.
- Snow Removal Contract Renewal Committee- Rod & Scott will be reviewing this along with several community members to gain input. Specifically, with regard to the snow removal and maintenance in the Rocky Hill project. After receiving a clearly outlined definition of expected services from Greenstone, the association and management will be working to develop a scope of work that meets all needs of the homeowners and stays within a suitable budget. This committee will also have community member Linda Ball.
- Landscape Contract Renewal Committee- John, Scott & Anne will lead this committee to seek a new company as the Clearwater Summit contract will be up for renewal, or replacement with a new professional.
- **Gray Hawk Monuments Committee-** Charlie will help lead this project with the help of Gray Hawk residents Paul Brown & Richard Shutts. Ensuring the company who started the work on the monuments will come to complete the project, as management and other board members have been unsuccessful in reaching Stone & Fire Construction.
- **Projects in Progress Review-** Association manager is gathering bids for 2019 audit professional, acquiring bids to do the pathway between Mission & Molter, and also getting bids for bark replacement in Rocky Hill.
- Avista Tree Project- Association manager has been in contact with Matt from Avista, and they will be providing an update as soon as possible. All projects have been placed on hold due to the COVID-19 restrictions.
